He hedged commodities primarily in the energy sector and has developed knowledge of options and commodity markets in general. He was a VP of Financial services for 5 years and was an account manager prior to that.

Item 4: Other Business Activities

Bryan Looper is an Associated Person and the branch office manager for HighGround Trading LLC, which is the Independent Introducing Broker. Bryan's office operates under the doing business as name (DBA) TERM Hedging & Consulting Inc., a division of HighGround Trading LLC. He spends 15-20 hours per week structuring custom tailored hedging programs to meet his client's needs and objectives, which includes setting up exchange trading accounts with Clearing members to trade futures and options, as well as bilateral third party accounts with major counterparties if that is what his client's needs are. TERM Hedging clients and LEFP clients always have the right to decide whether to accept and act upon our recommendations regarding such products. If either client does decide to accept and act upon recommendations from TERM Hedging or LEFP, they always have the right to do so through the professional of their choosing. Regardless, TERM Hedging and LEFP recommendations are intended to be consistent with our clients' needs and best interests.

Bryan is a High School(HS) Assistant Football Coach for Archuleta School District 50 JT. His coaching activities should have minimal impact on client service and operations as they are primarily outside of business hours. Expected time is 10 hours per week in evenings and on weekends during a normal season. It is a volunteer position with a stipend.

Bryan owns and operates Bronco Energy LLC, a company that owns, invests in, and maintains real estate which has minimal impact on client service, spending approximately 1 hour per month during trading hours on the business with the other 3 hours outside of trading hours.

Bryan also works with Leading Edge Growth, LLC on business consulting including business valuations, value growth advising and succession planning which may be sporadic, but average up to 3 hours per week.

Bryan has the conflict of interest to perform services from both TERM Hedging and LEFP to earn additional income.
